### Workplace Violence Accidental Death

### Upgrade to "Green" Coverage

- The price of supplies to repair/replace damaged property can be costly. We're providing coverage for an upgrade to "green standards". This applies to both LEED and non-LEED covered property. Coverage may be as much as \$2mm and includes up to \$25k for LEED recertification costs.

### Investigative Costs Expense Coverage

- If a crime loss occurs, many don't realize that there are often investigative expenses involved. We allow up to \$10k for reasonable and necessary costs paid to a forensic accountant to determine the existence of the crime and/or to determine the amount of the loss.
