COVERAGE HIGHLIGHTS

Business Income and Extra Expense with available limits of liability (depending on school type) up to:

- \$40,000 to \$400,000 Business Income & Extra Expense
- \$20,000 to \$200,000 per person
- \$500,000 to \$1,000,000 aggregate limit

Additional Expense included in the limit:

- First aid or emergency medical care for those injured
- Ambulance, hospital, medical, surgical, nursing and dental service for those injured
- Professional counseling for "affected parties"
- Fees paid to independent public relations firms
- Fees paid to independent security firms
- Funeral expenses
- Loss of income and extra expense

Coverage from date of event to as much as 60 days post event

- Students (as well as sponsored exchange students)
- Parents, guardians and spouses of those injured or held hostage
- Employees (as well as FT, PT and temp workers)
- School visitors (as well as guest speakers and volunteers)
